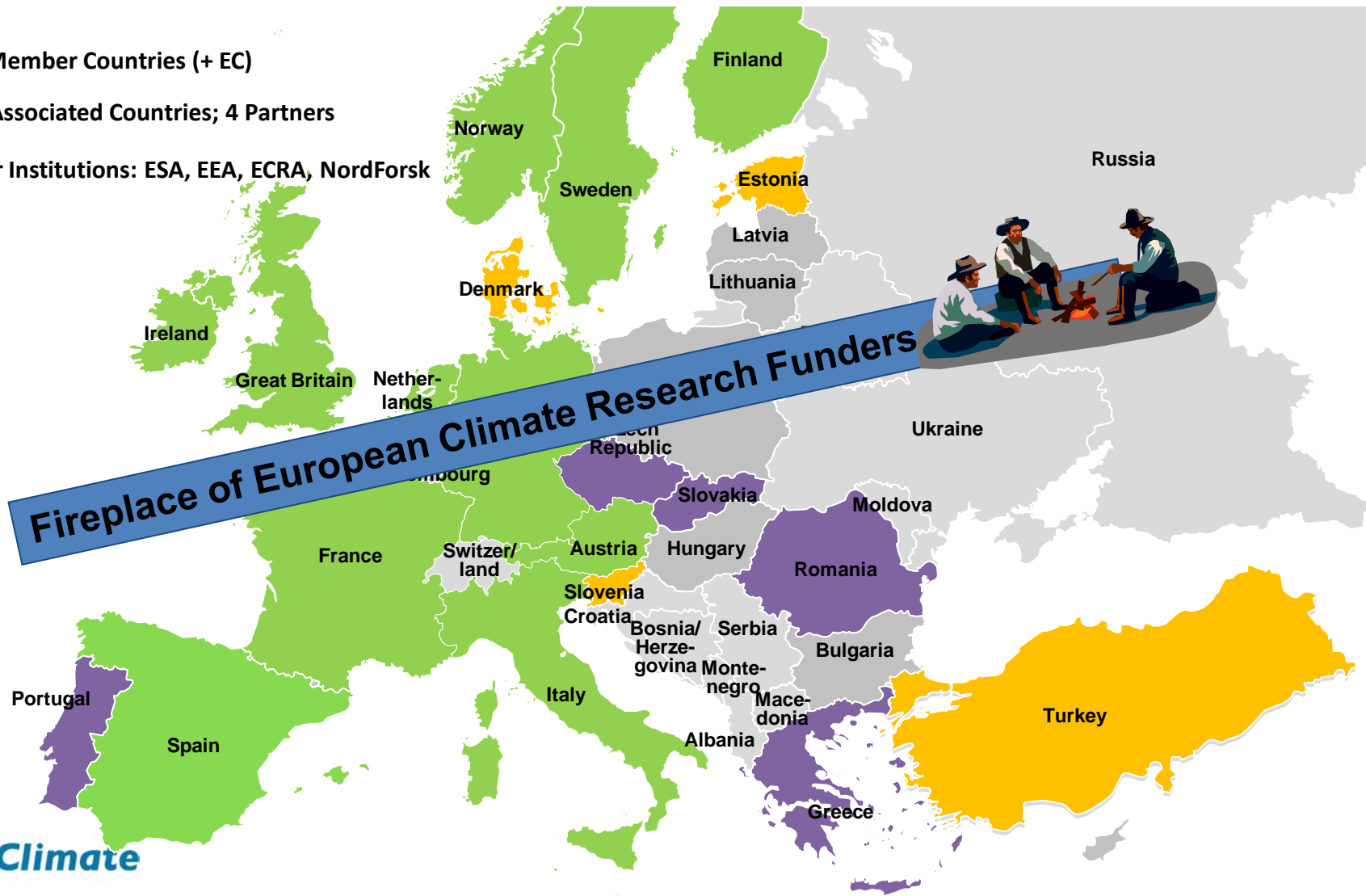

SC5-30-2017: ERA-NET on Climate Services Roadmap: **Cross-sector impact assessments (evaluation, comparison and integration)**

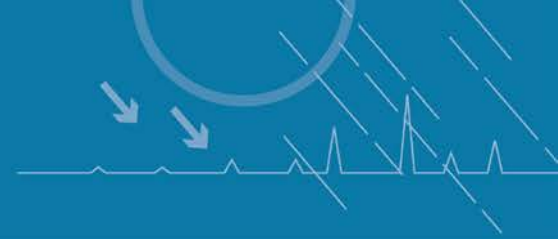
Specific challenge: Following the outcome of the European Workshop 'Towards a European Market of Climate Services' (18th March, 2014), a European Roadmap for Climate services has been prepared by an independent group of experts and presented in a subsequent European Conference on 17th March 2015. The Roadmap identifies a series of challenges and specific actions that need to be undertaken by various actors in Europe, in order to strengthen the European market of climate services. What is an ERA-NET Cofund action?



- H2020 Funding instrument in which
- ~70 % of funding comes from a consortium of member states
- Horizon 2020 gives a „top up“ of 33%
- Two basic funding types:
 - „**cash**“: national funders provide funding
 - „**in-kind**“: national research entities commit they institutional resources
- 2 call stages, then 2 proposal stages

Some parts of the Call Text:



Challenge:

- Context: **Climate Service Roadmap**, building on achievements so far
- *“... support knowledge-based decision making, both in the public and private sector, to avoid risks and seize opportunities towards sustainable development”*
- *“take into account **adaptation policies**”*

Scope:

- Reference to the framework of **SSPs** is given
- *„Open cooperation at international level with other key initiatives such as the **Belmont Forum** or at regional level in **Latin America** and/or **Africa.**”*

Some parts of the Call Text II:



Expected Impact:

- *increase the capability of **quantifying the impacts** of climate change at local/regional level in a **cross-sectoral** risk-assessment framework including better **quantification of uncertainties**;*
- *increase the potential of using climate impact data in operational climate services;*
- *increase the **integration of economic and impact model** assessments in support of adaptation and mitigation decisions;*
- *strengthen international **leadership of European research**, in particular its contribution to the WMO-GFCS, WCRP-**ISI-MIP** and the Future Earth Programme, and eventually to IPCC assessments, UN-SDGs and the Belmont Forum;*
- *contribute to implementing the **SDGs** and [...] the **COP21 Paris Agreement***

Status of ERA-NET



- Horizon 2020 WP currently in inter-service consultation
- Publication of WP soon (fall 2016)
- JPI Climate mentioned as targeted group of funders
- Envisaged EC-Budget: 13 M€
- This could leverage up to 26 M€ from countries: **max. 39 M€**
- Interest expressed by BE, ES, DE, FR, IE, IT, NL, NO, UK
- Initial interest also expressed by BELMONT Forum (tbc)

Next Steps:

- For synchronized call, decision needed at the next Belmont Forum meeting, **End of October** → ***Draft Call Proposal***
- **Key step: “Scoping Workshop”** JPI Climate with Belmont Forum by **mid to End September**
- Further Schedule:
 - Funders Proposal to H2020 by March/April 2017
 - Grant Agreement placed: ~ Fall 2017
 - Call opened: Early 2018
 - Call closed summer 2018
 - Projects to begin: **2019** (3 years project duration)

Possible direction of the ERA-Net (Funders) Call:

(all tbd, just my take)

- Not (only) more of the same
- more „**service**“ (more stakeholder interaction)
- more „**integration**“:
 - Cross-sector (e.g. food-water-energy nexus)
 - Cross-scale
 - Between impact and economic models
 - Study new linkages (such as ideas from yesterday)
- Include adaptation (+ adaptation economics?)
- For sectoral model improvement: **involvement of other JPIs** (FACCE JPI, JPI Water, JPI Ocean) will be checked
