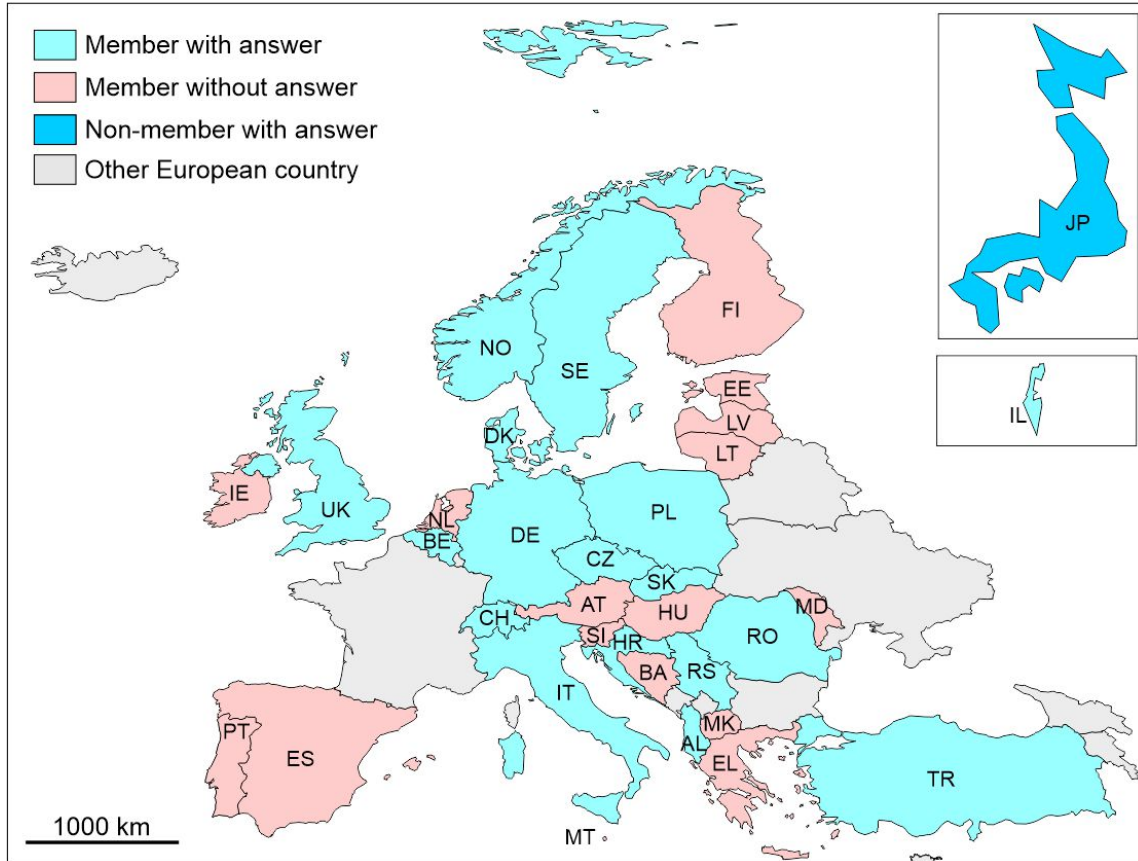

## 2. RESULTS ANALYSIS

### Geographical distribution of the countries involved in PROCLIAS Action and of the respondents

- 33 countries members of PROCLIAS Action\*
- 30 answers/peoples from 18 countries (one responded from Japan)
- 16 countries did not answer

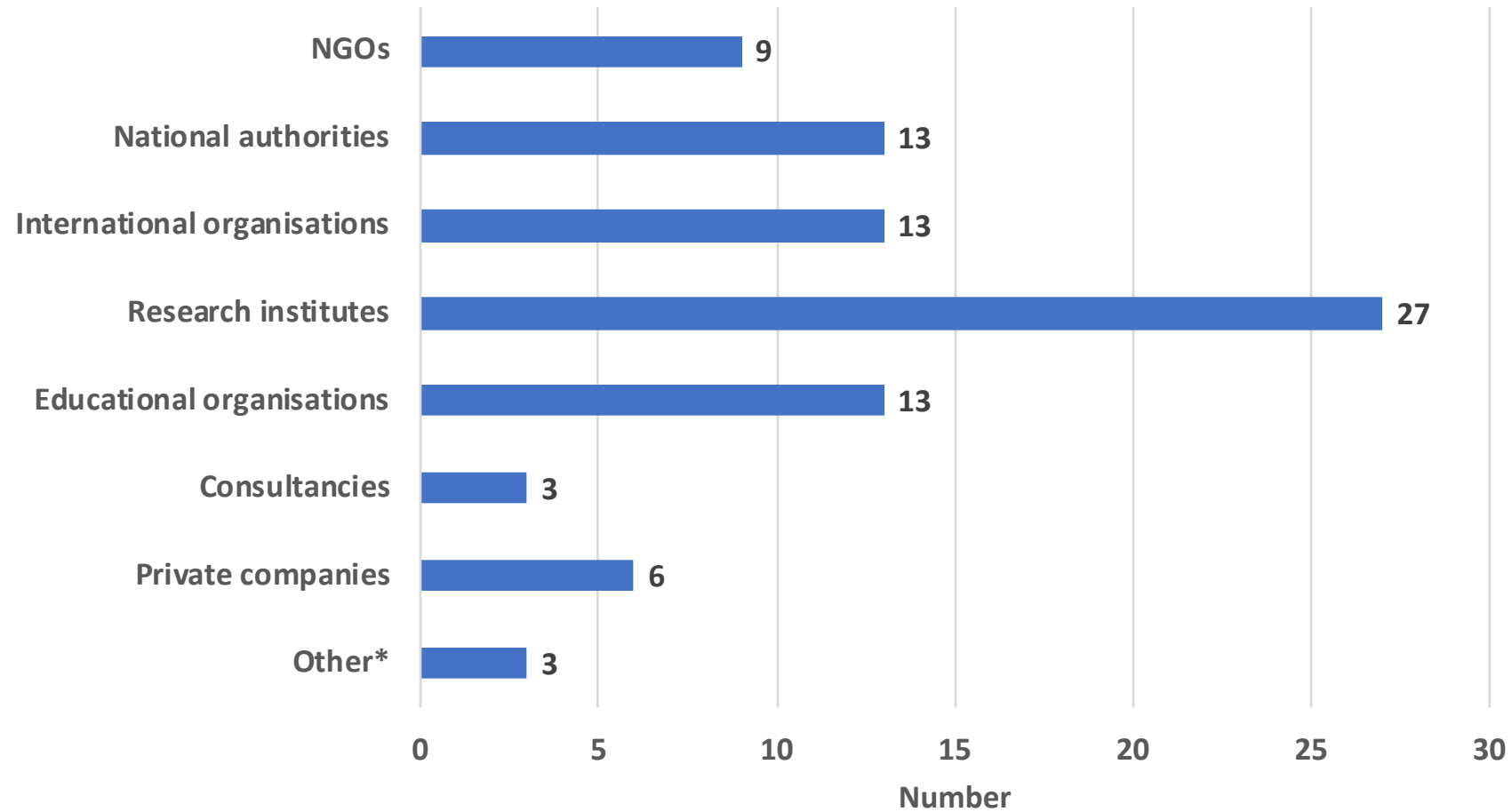

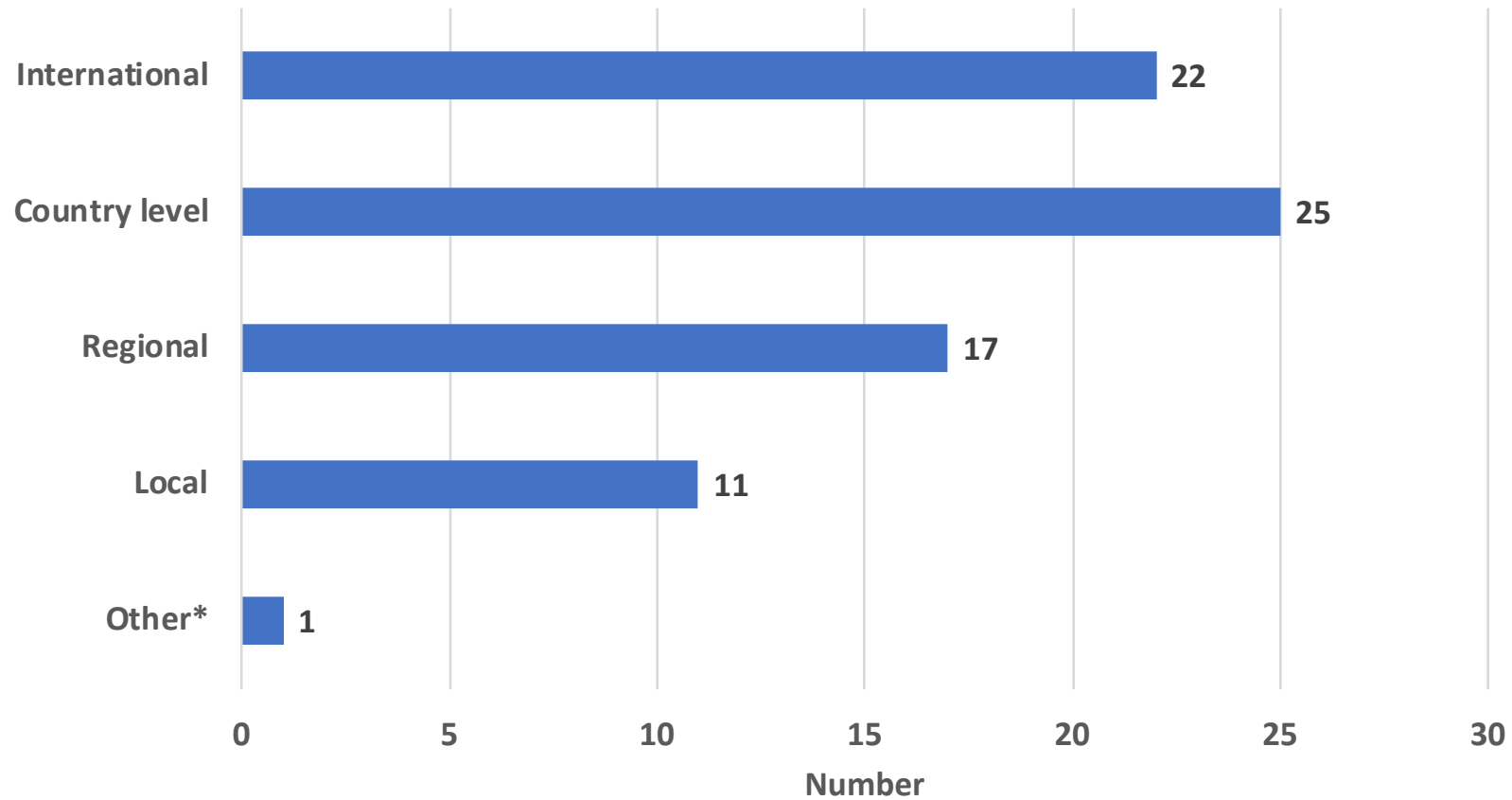

## Q5. What kind of organisations are particularly interesting for you to cooperate with under PROCLIAS ?



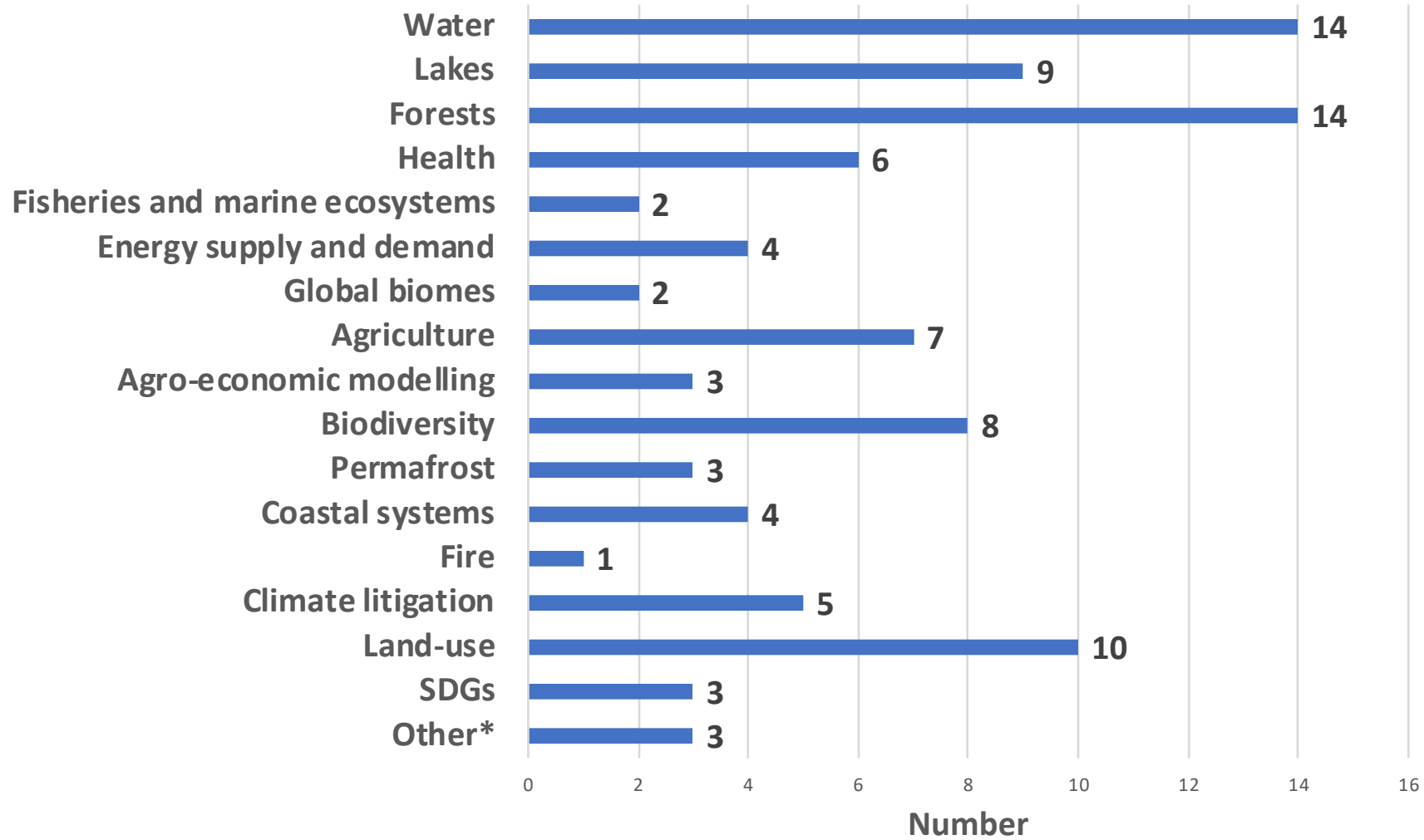

## Q6. What geographical/spatial scale focus would be of interest for you work?



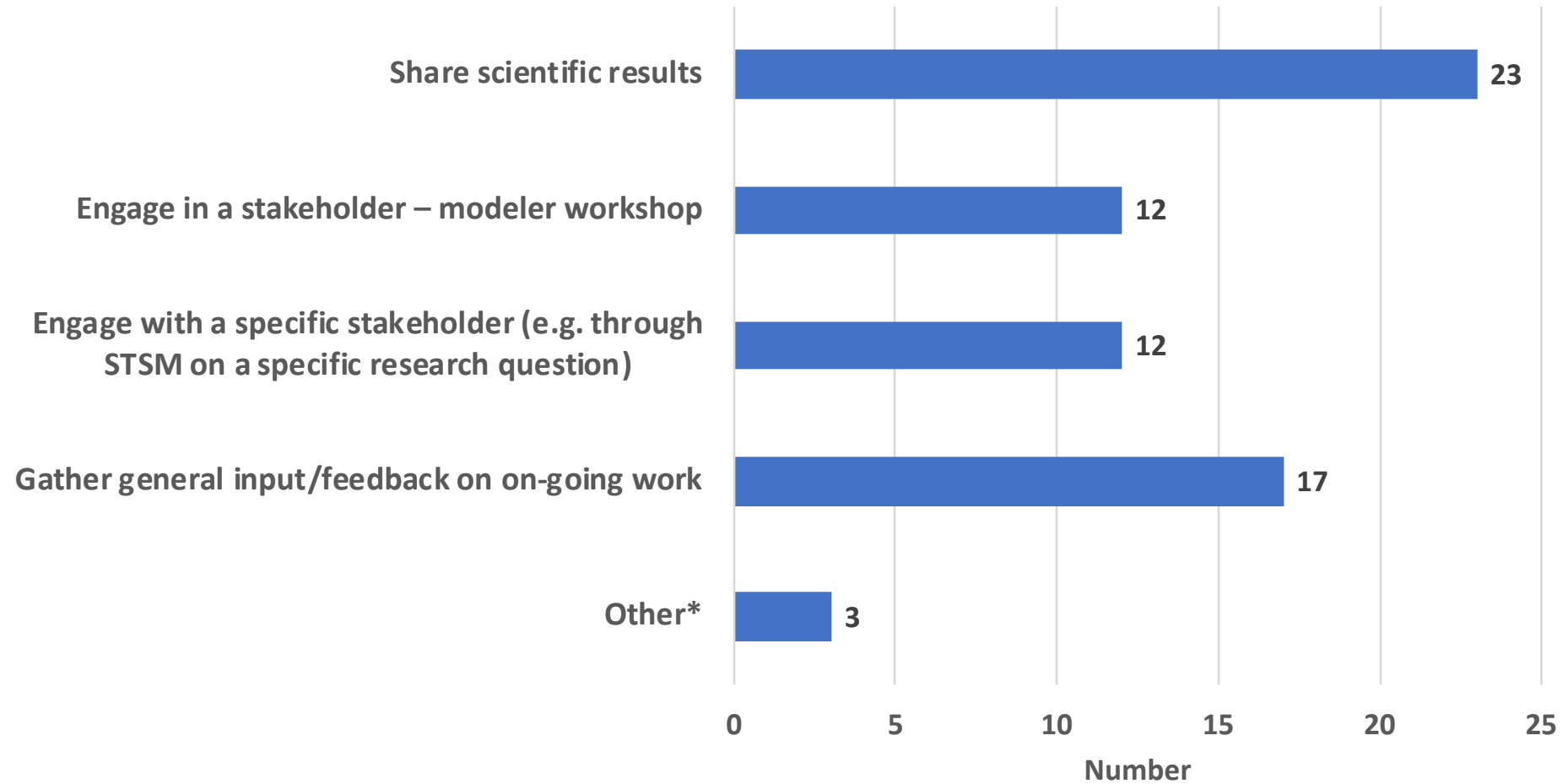
\*Other: specific sector

# CURRENT OUTCOMES

## 3. Design of a questionnaire to identify types of outputs and activities that are of interest for stakeholders engaging with PROCLIAS.

### ➤ 8 questions

Q1 - 4. Identification questions: name, e-mail, institution/ organisation and its location (city and country)

Q5. What is the type/profile of your institution/organization (9 options)

Q6. Which sector or wider topical focus is particularly interesting for you (7 options)

Q7. What type of engagement would you like to have with PROCLIAS Action (6 options)?

Q8. Any other comments

**To be lunched when we have a more comprehensive list of potential stakeholders.**

## EXPECTED OUTCOMES

- **Database with the identified stakeholders and their specific data to foster engagement with PROCLIAS members.**
- **Map(s) of the stakeholder's network to provide an overview of the interested / engaged stakeholders.**
- **Periodically updated spatial information related to the dissemination of the PROCLIAS project outputs and activities.**
- **Possibility to spread results to respective stakeholders or assess relevance of current and future research.**
- **More ideas are welcome – come join the breakout group!**

## CONCLUSION AND NEXT STEPS

Some progress has been made in TG4.2 within WG4:

1. Design and distribution of a questionnaire/survey addressed to PROCLIAS members.
2. Analysis of questionnaire results.
3. Design of a questionnaire to identify types of outputs and activities that are of interest for stakeholders engaging with PROCLIAS.

### Major problem encountered

So far, **very few** concrete recommendations for potential stakeholders were collected, many without contact details.

### Solutions/measures?

- To renew the request to fill the questionnaire by the PROCLIAS members.
- The respondents are asked to specify potential stakeholders **with concrete data allowing to contact them.**

- **Resend the questionnaire for PROCLIAS members.**
- **Start building the database with the identified stakeholders and drawing maps of the stakeholder's network.**
- **Share a questionnaire to the identified stakeholders to assess their interest.**
- **Get in touch with WG1 – WG3 for considering activities to involve stakeholders.**
